

The Top-20 index, main indicator of Mongolian capital market, reached the all-time high MNT 34116.86 units with market capitalization of MNT3,561,093,284,790.06 in last 30



NINTY PERCENT OF INVESTORS ARE PARTICIPATING ONLINE TRADING

Since Millennium IT system integrated system introduced into Mongolian capital market, number of online investors has been increasing rapidly every year using electronic devices such as mobile phones, computers, laptop and tablets.

For example, 33 percent of investors participated online trading in 2019, 70 percent of investors participated online trading in 2020. As of February 2021, an average of 2500 individuals and business entities are participating MSE trading daily and 85-90 percent of them participating online through 9 brokerage firms.

Increasing digital device usage for individuals and business entities during the lock-down of Covid-19 pandemic, securities online trading is positive impact on further expansion and development of the capital market as well as public interest of securities trading.

WORKING GROUP MEETING FOR ASGAT SILVER DEPOSIT HELD AT MSE



Parliament Standing Committee on Industrial policy established a working group to draft the resolution of Standing Committee to guide the Government and other relevant organizations on the economic development of Asgat Silver deposit. A meeting of the sub-working group to provide technical and methodological assistance to this working group was held at Mongolian Stock Exchange on February 03, 2021.

In the meeting, Mr.Aybakir, Head of working group and member of Parliament, Mr.Delgersaikhan, member of Parliament, Mr.Enkhtuvshin, member of Parliament, Mr.Nandinjargal, secretary of Ministry of Mining and Heavy Industry, Mr.Ganbold, a secretary of Ministry of Nature, Environment and Tourism, Mr.Tleikhan, head of Energy Regulation Committee, Mr.Altai, CEO of Mongolian Stock Exchange, and Mr.Bat-Erdene, consulting engineer were participated in the meeting.

During the meeting, Mr.Bat-Erdene, consulting engineer, Mr.Nyamdorj, Senior specialist of the Listing Department of MSE and Mr.Ganbold, Director of Metal projector in 'Erdenes Mongol' LLC, gave presentation on geological conditions of the deposit, Listing regulation and legal environment of MSE.

According to the Clause No.: 5.6 of Mineral Law of Mongolia, a legal person holding a mining license for a mineral deposit of strategic importance shall trade no less than 10% of its shares on the Mongolian Stock Exchange, and Action Plan for 2020-2024 of Government provides for conducting experiments, and research necessary to bring the Asgat Silver Deposit into economic circulation and to resolve investment issues.

ERDENES SOLUTIONS' JSC ACQUIRES 'ICE ASSOCIATE NBFI' LLC

'Erdenes Solutions' JSC, a Tier 3 listed company, informed that the Company has acquired 85 percent of common shares of 'Ice Association NBFI' LLC. In addition, 'Erdenes Solutions' JSC obtained the Copyright certificate for the D3 ARS system for Electronic data collection, document analysis and acquisition from Intellectual Property Office.

ERDENE ANNOUNCES THREE MONTH EXTENSION TO WARRANTS

Erdene Resource Development Corp (TSX: ERD, MSE:ERDN) has agreed to extend the term of the common share purchase warrants issued in connection with a non-brokered private placement, which closed in February 2019, other than those that were issued to insiders. Effective February 28, 2021, 10,265,222 warrants will have their expiry date extended by three months to May 28, 2021. The exercise price of \$0.50 and all other terms of the Warrants remain unchanged.
