





News highlights

REVISED PRIMARY MARKET TRADING RULES SENT TO FRC FOR ACKNOWLEDGEMENT

As the market has changed and demonstrated an increased number of new issues in recent years, Mongolian Stock Exchange has revised the Primary Market Trading Rules of 2009 and sent it to FRC for acknowledgement on November 01, 2018.

The price setting and allocation processes have been revised in accordance with the international best practices in the Rules. Also, it removed the overlapping and improved the practical application. For instance, it allows an underwriter to allocate up to 50 percent of the offering to strategic investors, and it sets top and bottom price bands in the book building approach which may be renewed once depending on the investor demands.

We have reflected suggestions received from market participants during the open discussion and all market participants supported the amendments.

TWO NEW MEMBER COMPANIES ADMITTED TO MSE

In accordance with the MSE Board Resolution No.2018/14 of October 26, 2018, "Central Securities" LLC, a brokerage company, and "Investor Capital" LLC, a company licensed to carry out brokerage, dealing and underwriting, have been admitted as a member company of the Mongolian Stock Exchange. Consequentially, the number of member companies of MSE has reached 61.

'CAPITAL MARKETS OPEN DAY' EVENT HELD IN ERDENET CITY

In order to improve market knowledge of rural citizens, Mongolian Stock Exchange JSC organized 'Capital Markets Open Day' event in Erdenet city during the days between November 14-18th, 2018 in cooperation with 'Erdenes Tavantolgoi' JSC and other market professional organizations.

During the event, training covering basic capital markets concepts and ways to participate in the market through investing and capital-raising were provided to local citizens from the rural areas, in addition to giving most up-todate information about 'Erdenes Tavan Tolgoi' JSC's 1072 shares distributed to all citizens and the remaining shares from pink and blue voucher state privatization programs. Overall, around 4000 citizens were involved in the event.

It is expected that the next events will be held in the eastern provinces.

ERDENE RESOURCE DEVELOPMENT CORP ANNOUNCEMENT

Erdene Resource Development Corporation, the first dual listed company on the Mongolian Stock Exchange, announced the filing on SEDAR of the National Instrument 43 -101 technical report regarding the mineral resource estimate for its 100%-owned, high-grade Bayan Khundii gold deposit,

one of two resource areas included in the Khundii Gold Project, on November 5th, 2018.

The Company also informed that they commenced a Preliminary Economic Assessment study for the Khundii Gold Project that was scheduled to be delivered in late Q4-2018 as well as initiated technical studies in support of the registration of the Khundii Project resources ahead of mining license applications for Bayan Khundii and Altan Nar planned for Q4-2018.
