





MSE RENEWS TOP-20 INDEX COMPOSITION

The TOP-20 index composition for the year 2020 has been renewed based on the performance of the securities in 2019.

As the TOP-20 index composition is renewed once a year in accordance with the "Regulation on Securities Index Calculation" of Mongolian Stock Exchange, the composition of the TOP-20 index has been renewed as the following for the year of 2020. Based on the performance of the stocks in 2019, 13 stocks have remained as a component security, while "Gutal" JSC, "Itools" JSC, "HBOil" JSC, "Genco tour bureau" JSC, "Makhimpex" JSC, "Darkhan Nekhii" JSC and "Talkh-Chikher" JSC have been removed from the index. The new constituents to the index composition include "Ard credit NBFI" JSC, "Invescore NBFI" JSC, "Monos khuns" JSC, "Tumen shuvuut" JSC, "Sharyn Gol" JSC, "Ulsyn ikh delguur" JSC and "Erdene Resource Development Corporation" JSC.

SECURITIES TRADING SUSPENDED FOR "BAYAN-ALDAR" JSC

According to the shareholders meeting of "Bayan Aldar" JSC held on April 8, 2019, the company made decision to divide the company's shares into 50 shares in total and sent enquires to Financial regulatory commission to make changes in securities register.

Therefore, according to the official notification of No 22 of state inspector of Financial regulatory commission dated January 16, 2020 "Bayan Aldar" JSC's securities trading has been suspended starting from January 17, 2020.

SECURITIES TRADING OF "MONGOL DAATGAL" JSC REOPENED

'Mongol Daatgal' JSC's securities trading has been suspended starting from December 17, 2019 due to the registration amendment process. Whereas, 'Mongol Daatgal' JSC's securities trading has been reopened starting from January 16, 2020 according to official notification No: 21 State Inspector of Financial Regulatory Commission.

ATTENTION TO THE SHAREHOLDERS OF GOBI JSC

Gobi JSC announced that the company will distribute dividend from its net profit for the year of 2018 and has placed a dividend into its shareholders account by December 31, 2019.

According to the decision of board meeting of Gobi JSC, since April 25, 2019 the company began to distribute dividend of MNT6.8 for per shares through company's office. However, accordance with the agreement within Mongolian central securities depository in December 25, 2019. The Company began to distribute balance of dividends from 2018 which amounts MNT 466,852,056.56 /amount with tax deduction/ for 16,473 shareholder's 76,352,838 shares by December 31, 2019.

"ARD CREDIT NBFI" JSC ANNOUNCEMENT

On January 10th, 2019, 'Ard Credit NBFI" JSC delivered the following announcement to MSE: "Ard Credit NBFI JSC was established in 2011 and has been operating under the applicable legislations and licenses issued by the Financial Regulatory Commission. In 2018, the Company was granted the license of "Electronic Payment and Remittance Service" by the Financial Regulatory Commission. However, the Bank of Mongolia has been in charge of all matters related to national payment system since January 01, 2018 due to the newly adopted Law on National Payment System. We have been informed that we need to get a license on electronic payment and remittance service from the Bank of Mongolia, and we applied for such license in September 2019. As the Bank of Mongolia required some additional documentation in reviewing the application, we are in the process of delivering those documentation to them.

"LENDMN NBFI" JSC PROVIDES ANNOUNCEMENT

On January 10th, 2019, LendMN NBFI JSC delivered the following announcement to MSE:

"In accordance with the Law on Non-banking financial activities and the Regulation on nonbanking financial activities, 'LendMN NBFI' JSC has been providing the Lend Wallet service under the licenses of "Electronic Payment and Remittance Service" and "Issuance of Settlement Instruments" granted by the FRC Resolution No.193 of May 23rd, 2018. The related approval can be viewed from the following link of the FRC website. "LendMN NBFI" JSC has approached the Bank of Mongolia for the clarification of the certain legal issues and inconsistencies and is working to resubmit the license application to the Bank of Mongolia as these issues are identified."

INVESCORE NBFI INVESTS IN KYRGYZ MI-CRO FINANCIAL COMPANY

InvesCore NBFI signs investment agreement with Zolotoi standard LLC of Kyrgyz Republic. InvesCore buys 100% of Zolotoi standard's shares and plans to launch its' fintech products in Kyrgyz market within 2020.

Zolotoi standard LLC was founded in 2004. It runs micro finance operation in Bishkek city with Micro credit company license. Main operation is collateralized consumer lending and SME business financing.

Under its' mid-term plan, InvesCore expands its operation into Central Asian market, starting with Kyrgyz.

ERDENE COMMENCES BAYAN KHUNDII GOLD PROJECT BFS AND PROVIDES TECH-NICAL, PERMITTING AND EXPLORATION UP-DATE

In late December 2019, Erdene launched the FEED and BFS required for permitting, project finance, and board approval to construct. The independent BFS will be prepared in accordance with National Instrument 43-101 Standards of Disclosure for Mineral Projects ("NI 43-101") and will incorporate an updated mine design study, FEED for the processing plant and associated infrastructure, a hydrogeological study, detailed waste management plans, and an updated economic model. The Company expects to deliver the BFS in mid-2020.
